Erie County Community Foundation's new Program Officer, Heidi Schlesselman comes to the Community Foundation after most recently serving as the Market Manager for BCSN Erie, where she led strategic initiatives to enhance local media presence and community engagement

In Schlesselman's new role at the Community Foundation, she will be responsible for managing and evaluating the Foundation's discretionary grants, Donor Advised Fund grants, and Youth Advisory Council grant programs. She will also oversee the Foundation's scholarships programs, maintaining records on scholarship funds and student recipients in compliance with state, federal and IRS requirements. Schlesselman will serve as liaison to the Erie County Community Foundation Scholarship Committee, high school and college counselors, donors, and students to increase the number of students applying each year for scholarship assistance.

Schlesselman is a graduate of Bowling Green State University with a strong background in Marketing, Media, and Event Planning. She has gained extensive experience working with various media outlets and professional sports teams.
